Missions are advised to submit an electronic version to the respective addresses below and kindly deliver the Original Document at the Diplomatic Immunities and Privileges (DIAP) Reception.

The Department further wishes to inform Missions that all the old diplomatic license number plates will be declared illegal and not registered from 1 June 2013. This final decision is subsequent to the due dates to have the old number plates changed to the new numbers, being extended twice. As Missions may appreciate that the local law of the host country should at all times be adhered to, the relevant authorities such as the South African Police Services (SAPS) and Diplomatic Police Unit will be informed and vehicles still using the old diplomatic license number plates will be dealt with in accordance with the local law.
